CONDITIONS

1. Sec. 9 (1) of Private Security Agencies (Regulation) Act.2005 every private security agency shall, within six (6) months of obtaining license commence its activities.
2. Sec. 9 (3) of the Private Security Agencies (Regulation) Act 2005 every private security agency shall, within sixty days from the date of issue of license employ such number of supervisors and security guards as may be prescribed.
3. Private Security Agency should follow the rules framed under the Dadra and Nagar Haveli Private Security Agencies Rules, 2009 and is obligatory to act under Private Security Agencies (Regulation) Act, 2005.
4. Sec. 10 (1) Sub Section (a) Private Security Agencies (Regulation) Act.2005 every private security agency shall not employ or engage any person as a private security guard unless he is a citizen of India.
5. Sec. 12 of the Private Security Agencies (Regulation) Act.2005 every private security agency shall exhibits its license or copy thereof in a conspicuous place of its business.
6. Rule 4(1) of Dadra and Nagar Haveli Private Security Agencies Rules, 2009 the private security agency before employment of person or engage as a security guard or supervisor the agency shall satisfy itself about the character and antecedents of such person in manner.sub rule (2) The person desire to getting employed or engage as Security Guard or Supervisor shall submit his particular in Form-II within one month on receipt of the license to the Controlling Authority. Sub Rule (3) The Agency shall cause an inquiry into the correctness of the particulars filled in either by itself or by sending the Form-II to the Superintendent of Police for verification. Sub Rule (4) While sending the form to the Superintendent of Police for verification, the Agency shall pay fee of Rs. 1000/- (Rupees One Thousand Only) if it is within the state, or Rs. 2000/- (Rupees Two Thousand Only) if his domicile has been outside the state in the form of Demand Draft or Banker's Cheque drawn in favour of the **"Superintendent Of Police"**, Dadra and Nagar Haveli, Silvassa. Sub Rule (9) The Character and Antecedents verification report once issued, will remain valid for three years. Sub Rule (10) On the basis of Police Verification and on the basis of their own verification, the Agency shall issue in Form-III a character certificate and this certificate will not be taken back by such Agency, even if the person ceases to be the employee of that Agency.
7. Rule. 6 of the Dadra and Nagar Haveli Private Security Agencies Rules, 2009 every private security agency shall, fulfills the standards of physical fitness as specified and the agency shall ensure that every security guard working for it undergoes a medical examination after every 12 months from his last such examinations so as to ensure his continued maintenance of physical standard as prescribed for the entry level.
8. Rule 10 (1) of Dadra and Nagar Haveli Private Security Agencies Rule 2009. The licensee shall successfully undergo a training relating to the private security service prescribed training syllabus as per Annexure - II and the list of private security supervisor/ guards successfully completed training shall be provided to the Controlling Authority.
9. Rule 10 (2) of Dadra and Nagar Haveli Private Security Agencies Rules, 2009 the licensee shall intimate the name, parentage, date of birth, permanent address, address for correspondence and the principal profession of each person forming the agency within 15 days of receipt of the license to the Controlling Authority.



10. Rule 10 (3) of Dadra and Nagar Haveli Private Security Agencies Rules, 2009 the licensee shall inform the Controlling Authority regarding any change in address of persons forming the Agency, change of management within seven (7) days of such change.
11. Rule 10 (4) of the Dadra and Nagar Haveli Private Security Agencies Rules, 2009 The licensee shall immediately intimate to the Controlling Authority any criminal charge framed against the person forming the Agency or against the private security guard or supervisor engaged or employed by the Agency, in the course of their performance of duties as Private Security Agency. A copy of such communication shall also be sent to the officer Incharge of the Police Station where the person charged against resides.
12. Rule 10 (5) of the Dadra and Nagar Haveli Private Security Agencies Rules, 2009. The licensee shall abide by the requirement of physical standard for the private security guards and their training as prescribed Annexure -II in these rules as the condition on which the license is granted.
13. Rule 10(6)) of the Dadra and Nagar Haveli Private Security Agencies Rules, 2009 Save as provided in this rules, the fees paid for the grant of license shall not be refunded.
14. Rule. 14 of the Dadra and Nagar Haveli Private Security Agencies Rules, 2009 private security Agency shall, maintain required register under the act as prescribed in Form - VIII.
15. Rule. 15 of Dadra and Nagar Haveli Private Security Agencies Rules, 2009 private security agency shall issue photo identity card under sub-section (2) of section 17 of the Act shall be in Form - IX.
16. Rule. 16 of Dadra and Nagar Haveli Private Security Agencies Rules, 2009 private security agency shall fulfill the clothes / uniform worn by the Private Security Guard while on duty and also take into the notice that, it should not bear any of the distinctive marks of the uniform used by the Army, Air Force, Navy or any other armed force of the Union or Police.
17. The Private Security Agency shall intimate the Controlling Authority about the fresh appointment or termination or leaving the agency by the Security Guard or Supervisor within 48 hours.
18. If the Private Security Agency violated any condition under Act / Rules of Private Security Agency shall also be punishable under section 188 of Indian Panel Code (IPC), which will be cognizable and non bailable offence, also liable to be cancel/suspend the license by the Controlling Authority.
