CONDITIONS :-

1. This licence is only for private security agency work. This does not grant any permission to engage in intelligence collection, detective agency work or any other such activities.
2. Validity of Licence is for the period of five years from the date of issue unless mentioned otherwise.
3. The licensee shall commence his/her business within 6 months from the date of issue of Licence (Sec 9 of PSAR Act).
4. The licensee/firm shall comply with the provisions of State Insurance/EPF/GST etc. as per the existing rules/law.
5. The licensee/firms shall ensure that guards and supervisors undergo the required training as per the provisions of PSAR Act 2005 (Standing Order No. II* date 10.02.2017 issued by this Department shall be complied with strictly).

6. Police verification of guards and supervisors will be the responsibility of licensee/Firms.
7. As per rule 9 of PSAR Act 2005, Medical Examination after every 12 months for guards and supervisors is compulsory and a Specimen Certificate to that effect is attached. (To be read with the Standing Order no. II* dated 10.02.2017 of Controlling Authority) The Licensee /Firms shall provide list of Security guards, their training certificates and their medical examination as per standing order mentioned above. Licensee/Firms shall apply for renewal of Licence on or before 45 days of expiry of his/its Licence.
8. The Original Licence shall be deposited with this office on Expiry of Licence or on closing of Security business.
This Licence is valid for providing security guards only as per the provision of PSAR Act, 2005 and Rajasthan Regulation Rules 2022.
9. The provisions of the Schedule of section 13 (j) of the Private Security Agencies (Regulation) Act- 2005 shall be followed.
10. In case of any litigation jurisdiction shall be Jaipur city only.
11. The Licensee shall ensure enlisting 25% of the total strength from duly trained Home Guard Volunteers.
12. *The Copy of Standing Order no. II is attached; herewith; for compliance.
- N.B:- In case of non observance/non compliance of above mentioned conditions the Licence issued hereunder shall be liable to be cancelled and punitive/criminal action may also be initiated.
13. The Licensee shall ensure compliance of all relevant provision of PSAR Act 2005 & RPSA (Regulation) Rules -2022 as stated in the advisory issued by Controlling Authority on 15.06.2020 (Copy attached)
